#### 1 QUORUM AND OPENING OF THE MEETING

With a quorum of the members of the Council of Commissioners of the Kativik School Board being present at 2:05 p.m. on March 29, 2007. Opening prayer led by Alicie Nalukturuk.

#### 2 NOTICE OF MEETING

The President ascertained that all members of the Council of Commissioners have received notice of this meeting.

#### 3 CHAIRPERSON

On a motion moved by Charlie Watt Jr. and seconded by Sarah Beaulne, Alicie Nalukturuk is appointed to chair the meeting.

#### 4 ADOPTION OF AGENDA

Harriet Keleutak reads the agenda. The Agenda was modified and adopted as attached to the minutes as **Annex I**.

## 5 SCHOOL CALENDAR GUIDELINES

Annie Grenier informed the meeting that we need to discuss the school calendar quidelines for the school year 2007-2008. Harriet Keleutak read the information.

Martin would like to know if they could use Saturdays, Sundays and evenings for ped days. Elias replied by saying that they could.

Adamie Alayco wonders why the dates for Christmas are not set yet. Annie replied by saying that they are waiting for the work calendar.

Charlie Alaku asks about the statutory Holidays on page 4 and about the Aboriginal Day whether it is recognized. He wants it to be reviewed because it is recognized by the Government. Mary replies by saying that it is in the Collective agreement and we use it that way; and as for others in Nunavik, they use it with Health board.

Alasie says they use it but not to take the day off.

Charlie from Quaqtaq says he recalls a limit of 3 days that they used.

Mary says that they are 3 days, and it can create a problem if they don't have any recuperation days.

Adamie Alayco wonders if they are going to be like last year.

Alasie replied by saying that the starting date and the last day will be written.

Adamie says that they talked about it in the past and it would also be good to have some feedback from the parents. Mary asks Adamie if he read the information given for the meeting.

Charlie Watt Jr says they are asked questions from the community about the calendars and it would be nice to have something to answer with.

Charlie Tukkiapik says that the ones we were going to use to inform our community it would have been only June.

Mary says if the information was too long to read, it would be complicated. Until 2010, we will have it in the collective agreement.

Adamie Alayco would like to know if they could put days aside for goose hunting. He also would like to know if the teachers, during their training this summer, could be informed. Mary Aitchison replied by saying that they could use three days.

Willie Tomassie Jr. would like to know when these calendars were approved.

Alicie Nalukturuk replied by saying that they was approved during the 2003-2004 school year.

Betsy explained by saying for the school year 2007-2008, the start date will be August 20, 2007 and 20 and 21 will be Pedagogical days. The students will start on August 22 or 23. The end date for the teachers will be June 20, 2008 and students would finish on June 16 or 17, 2008.

On a motion moved by Adamie Alayco and seconded by Charlie Alaku the resolution number 2006-07-26 is approved with 3 absent.

WHEREAS the Council of Commissioners have been consulted and submitted recommendations with respect to the guidelines for school calendar for the school year 2007/2008;
