**FUNCTION & DUTIES:**

Under the supervision of the Assistant Director of Second Language Curriculum Development, this position entails the responsibility of providing advice and support to schools in the implementation, development and evaluation of the Career and Community Development and Work-Oriented Training Pathways programs of study.

- Support and ensure high quality, culturally relevant and alternate education in Nunavik communities specifically in line with alternative Career, Pre-work and Apprenticeship educational programs;
- Work in collaboration with the Adult Education, Vocational Training team, Inspire Nunavik, and community organizations and local job placement partners;
- Participate in the development of the programs and pedagogical material that are aligned to Inuit culture, language and community needs and values;
- Lead training sessions / workshops with teachers and local businesses and organizations in person or with technological support (virtual class, videoconference and others);
- Follow up on inventories of material and budgets for the Work-Oriented Training Pathway programs;
- Support specific project-based models practiced in the 14 schools using creative thinking and problem solving skills;
- Attend career education and related conferences as presenters or participants to share knowledge;
- Carry out related tasks at the discretion of the immediate supervisor.

**QUALIFICATIONS:**

University degree in a relevant field of specialization. CEGEP and vocational accreditations may also be considered.

*The Board may, at its discretion, waive any or all of the afore-mentioned qualifications if it finds a suitable candidate who is a beneficiary of the James Bay and Northern Québec Agreement (JBNQA) and who accepts, as a condition of employment, to follow a training plan determined by the Board.*

**ASSETS:**

- Legal qualification to teach in the province of Québec, or other province of Canada;
- Experience as a teacher or youth worker, trainer or experience in trades, or program developer;
- Computer literacy;
- Strong communication, networking, and relationship-building skills;
- Knowledge of Inuktitut, French and/or English is essential.
